Anti social behaviour/dangerous driving

Surveillance Camera Project 24th November 2020 – Part 1 Project Update

Project sub-group: Cllrs. Stones, Manning & King, Parish Clerk.

Anti-social behaviour Issue:



- During snowy & icy conditions the parish of Dartmoor Forest, and in particular the village of Princetown, is visited at night, by car drivers who use the conditions to race their cars, perform stunts and drive significantly in excess of safe, legal speeds. This anti-social behaviour endangers the people, property and peaceful existence of the parish.
- This activity has significantly affected Princetown over a number of decades.

Background to CCTV Scheme



- In June 2018, to try and understand the scale and impact of the issue, the parish council surveyed local residents and received over 40 responses which demonstrated the level of disruption and concern this behaviour caused.
- The parish council then presented the results to representatives of Devon County Council Highways, West Devon Borough Council (WDBC), Devon and Cornwall Police and the Office of the Police and Crime Commissioner for Devon and Cornwall (OPCC). The objective was for them to understand the impact of this anti-social behaviour and explore what could be done to significantly reduce this behaviour.

High Level Scheme:



- Devon and Cornwall Police advise that they will always try and attend to reports of this behaviour, however there are often many other urgent calls that they need to prioritise. They also have significantly less resources available.
- However, if the Police have evidence of cars being driven dangerously then they can take the matter further.
- In addition, WDBC can also issue 'Community Protection Notices'. These are written warnings, issued to drivers of vehicles reported to be causing nuisance, anti-social and sub-criminal behaviour.

High Level Scheme:



- The information about cars driving dangerously could be reported by members of the community. However, this can place residents at risk, especially in dark and dangerous driving conditions.
- During discussions with Devon & Cornwall Police, the OPCC and WDBC it was agreed that a CCTV/Surveillance Camera operation could act as an effective deterrent.
- The information recorded on CCTV could either be accessed directly by the Police and WDBC, or downloaded by the Parish Council and passed onto them for follow up action.
- The use of CCTV would need to be reinforced by strong governance arrangements, highly visible signage and an effective, ongoing communications strategy.

Project Requirements:



- Permissions from relevant authorities
- Consultation with local community and other interested parties
- Governance to ensure that system is used legally and correctly
- Specialist Contractor to install and maintain system
- Finance to fund and maintain any solution

Permissions:



- Planning Chris Hart, DNPA Planning, has advised verbally that planning permission will not be required. However, all solutions propose that cameras are sited on the Visitor's Centre. This is a Historic Building and therefore any installation will need to be sited sensitively. Planning will need to approve this. However, it does not require a formal planning application.
- DNPA have given permission as tenants of the Visitor's Centre for cameras to be sited on the building if owner, Duchy of Cornwall, approves.
- Duchy of Cornwall Tom Stratton has confirmed that the Duchy permit the cameras to be sited on the Visitor's Centre.

Consultation:



- Community the Parish Council wrote to all Princetown households in December 2018 and notified residents that the council were considering a CCTV solution.
- Community the Parish Council held a consultation drop in event to gauge resident's opinions. This was attended by 4 parish councillors and 2 members of the public.
- Community propose that an update on the project is provided on the council's website and Facebook page.
- Devon & Cornwall Police Inspector Sloman, West Devon Sector Inspector, has reconfirmed his support for the project.
- WDBC John Ward, ASB Officer has previously expressed his support for the project. Clerk due to discuss on 23rd Nov.
