- **9. Warren House Inn** Clerk had written to Highways raising concern at the commercial impact of road closures on the public house. Highways communicated to the council and the proprietor that the closures would not be for the full 5 days but for a very limited time in the morning. It was advised that the proprietor was satisfied with this response.
