- 2. Declarations of Interest No further interests declared.
- **3. Princetown CCTV Project** Clerk provided the following update:
 - a) Installation scheduled 19th January 2021, system expected to be operational within a few days of this.
 - b) Devon Highways are required to approve signage and locations. Final details of lamppost locations have been surveyed by Cllr. Worth and will be submitted to Highways as soon as possible.
 - c) Data Protection Impact Assessment the council resolved to approve this document.
- 4. Dartmoor 'Snow Tourist' parking and access issues the council resolved to convene a meeting of all appropriate authorities, including; Devon & Cornwall Police, Devon Highways, West Devon Borough Council, Dartmoor National Park; Devon & Somerset Fire & Rescue Service and other affected parishes to develop a plan to address the issues of inconsiderate & irresponsible driving and parking on the moor. Although a similar meeting had been held in 2015 on this issue, it was agreed that any future meeting and actions should be led by Dartmoor Forest Parish Council.
